Based on the 28th article of the statute of the University of Primorska (Ur. I. RS, no. 51/15 UP-UPB2 and changes), the rector of University of Primorska, prof. dr. Klavdija Kutnar, issues the following

DECISION on measures to prevent the spread of COVID-19

I.

From 22 November 2021, the following measures to prevent the COVID-19 disease are in place:

UNIVERSITY ACTIVITIES

All university activities are allowed at the premises of the University of Primorska for students and staff, while external visits are limited.

In doing so, all staff, students and visitors, who are entering into the university premises, fulfil the vaccine/test/recovery system:

- *VACCINE: full vaccination done,*
- *TEST: negative RAT or PCR test not more than the number of days required by governmental decrees. Students and staff can also fulfil test requirement with a self-test,*
- *RECOVERY: in the period of 10-180 days from the start of the symptoms or a positive PCR test.*

University members guarantee studies to students of specific study programmes under the same conditions and in line with equal opportunities.

DISTANCE WORK AND STUDIES

Staff works at their usual location.

Students and staff with health limitations can work and study distantly. Following physicians' recommendations, individual study programmes are prepared for students, while leadership makes an individual agreement with the staff, which can include a temporary order to work from home.

Work and studies from home are also enabled to all in quarantine or self-isolation.

ORGANISATION OF PUBLIC EVENTS

Public events run distantly. **Extracurricular activities, lifelong learning and other similar activities**, which cannot be implemented on-line or postponed, can be implemented for students and staff, while all instructions and recommendations of the National Institute of Public Health have to be observed.

RECREATION

Recreation of students and staff is allowed under the condition that the measures defined in governmental decrees for sport and recreation against the spread of COVID-19 disease are observed.

BUISNESS TRIPS AND MOBILITIES

Business trips abroad and outgoing international mobility of students and staff lasting more than a month are allowed without limitations. Shorter business trips and mobilities are allowed, under the condition, that quarantine is not required at the destination, on the way and upon return. If the quarantine is required, mobilities are allowed with prior consent from the rector or the dean or director of a university member. Incoming mobility is permitted, following decrees defining conditions for border crossing.

GUIDELINES

The Rectorate prepares general guidelines for working, pedagogical processes and knowledge assessment, while university members prepare individual protocols, taking into account specifics of their premises. All students and staff have to be familiar with the guidelines, before they enter the university premises. All National Institute of Public Health guidelines regarding the COVID-19 disease have to be observed.

Student Residences and University Library prepare their own specific guidelines.

APPEALS

We appeal to all students and staff to take consistent care of hand hygiene and cough and to follow general hygiene measures to prevent the spread of disease,

We appeal to limit contacts with external visitors.

We appeal to all students and employees to follow the verified and official information, especially the NIJZ and WHO.

We appeal to all students and staff to prevent discrimination and respect for fellow human beings.

II.

This decision repeals decision 1142-146/2021 of 25 September 2021.

The decision shall enter into force immediately and shall remain in force until revoked.
