STATEMENT ON THE FULFILLMENT OF THE CONDITIONS FOR CO-FUNDING TUITION FEES IN DOCTORAL STUDIES FOR STUDENTS OF THE UNIVERSITY OF PRIMORSKA IN STUDY YEAR 2021/2022

In accordance with the Decree on 23 the co-funding of doctoral studies (Official Gazette of the Republic of Slovenia, No. 22 as of 28 April 2017 and No. 105 as of 23 July 2020)* and the Criteria for the selection of candidates for co-funding tuition fees in doctoral studies at the University of Primorska adopted at the UP Senate 2nd correspondence session held from 15th to 17th April 2020**.

I, the undersigned, _____

would like to have the cofinanced tuition fee for my ____ year of doctoral studies in study year 2021/2022.

With my signature I confirm that I meet the criteria for co-funding tuition fees in doctoral studies marked below:

- I' am enrolled in the 1st year of doctoral studies in study year 2021/2022 and the average grade of my exams at the previous level of study is 8;
- I' am enrolled in the 1st year of doctoral studies in study year 2021/2022 and the average grade of my exams at the previous level of study is not 8 but I have a scientific publication (in attachment);
- I' am enrolled directly in the 2nd year of doctoral studies in study year 2021/2022 according to the criteria for transferring between study programmes and conditions for accelerated advancement and the average grade of my exams at the previous level of study **is 8**; the average grade of my exams at the previous level of study **is not 8** but I have a scientific publication (in attachment);
- I' am enrolled in the 2nd / 3rd year of doctoral studies in study year 2021/2022;
- I have regularly advanced to the 2nd or 3rd year of doctoral studies in the study year 2021/2022 and in the previous years of my doctoral studies. Extension of status for justified reasons in accordance with the law governing higher education and the Statute of the University of Primorska shall also be considered as regular advancement/promotion.
- I have not yet obtained the level of education matching the level of education obtained under third-cycle doctoral study programmes;
- my studies under doctoral degree programmes to obtain a PhD, regardless whether they have been completed, are not or have not been co-funded from public funds¹ (Young Researchers, Public call for co-funding tuition fees in doctoral studies at the University of Primorska - generation 2016);

¹ Does not apply to students who in the 2018/2019, 2019/2020 and 2020/2021 academic years received co-funding under the Public Call for co-funding tuition fees in doctoral studies at the University of Primorska for generations 2018, 2019 and 2020.

- I am aware of the consequences of making a false or incorrect statement indicating that I am not eligible for co-financing in the academic year 2021/2022.

Personal data protection

With my signature I confirm that all my personal data stated above may be collected, managed and transmitted in accordance with the Law on the Protection of Personal Data (Official Gazette of the Republic of Slovenia, No 94/07-ZVOP1) and Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (General Data Protection Regulation) (OJ L 119, 4. 5. 2016, pp. 1-88), for the purpose of monitoring and reporting to the Ministry of Education regarding the implementation of co-funding of doctoral studies.

I am informed about my rights in relation to the personal data transmitted:

- that I can request access to my data, correction, deletion or transfer of these data and restrictions on their processing, that I can complain against processing; that I can cancel my consent at any time (the request for deletion of personal data has to be sent in writing to the University of Primorska ,Titov trg 4, 6000 Koper or at the email address: szrrd@upr.si;
- that I can make a complaint to the competent supervisory authority if I believe that the personal data manager is violating the rules on the protection of personal data;
- that I can read the information about the manager, the authorized person for the protection of personal data and other information regarding the use and protection of personal data on the web address www.upr.si;
- that the personal data provided will not be processed for any purpose other than those mentioned above;
- that personal data will not be transmitted to third parties, with the exception of the competent ministry which monitors the implementation of the funding of doctoral studies;
- personal data transmitted will be kept for as long as is necessary to achieve the purpose for which these data were collected or until the withdrawal of personal consent.

Doctoral students meeting the conditions and criteria for co-funding tuition fees in doctoral studies and are interested in co - funding in study year 2021/2022 must complete, sign and submit this Statement at the Faculty conducting their doctoral study programme no later than 25th September 2021, when the Call for enrolment into doctoral degrees Study Programmes is closed!

*In accordance with the Decree on the co-funding of doctoral studies (the tuition fees for co-funding of doctoral studies may be granted to students meeting the following requirements:

1. they are enrolled in the 1st, 2nd, 3rd or 4th year of doctoral studies and regularly advanced to the 2nd and 3rd year of doctoral studies;
2. they have not yet obtained the level of education matching the level of education obtained under third-cycle doctoral study programmes;
3. their studies under doctoral degree programmes to obtain a PhD, regardless whether they have been completed, are not or have not been co-funded from public funds

CROSS ENROLMENT IS NOT CO-FUNDED.

**Criteria for the selection of candidates for co-funding tuition fees in doctoral studies at the University of Primorska states that co - funding will be provided for candidates meeting the following criteria:

- a.) Doctoral students that have received co-funding fees following the Call for enrolment in the academic years 2019/2020 and 2020/2021 that have regularly advanced to the 2nd or 3rd year of doctoral studies are, when they complete and sign the *Statement on the fulfillment of the conditions for co-funding tuition fees in doctoral studies*, automatically entitled to the co-funding tuition fees in the current academic year.
- b.) Doctoral students applying for the first time to the Call for enrolment into the Doctoral degree programmes will be co-funded when they complete and sign the Statement on the fulfillment of the conditions for co-funding tuition fees in doctoral studies if the average grade of exams at the previous level of study is 8 or if they have a scientific publication. The relevance of the publication has to be approved by the Commission for Scientific Research and Development of the UP.
