**ADDITIONAL OPEN CALL UNDER ERASMUS+ (KA103) FOR
STUDENT MOBILITY FOR TRAINEESHIPS
IN THE ACADEMIC YEAR 2020/2021 (contract year 2018)**

GENERAL CONDITIONS

Students of the University of Primorska (UP), who have a status of full time or part-time student on undergraduate and graduate programmes of UP and will have it during the whole mobility period, can apply to an open call for mobility for traineeship.

Students have to be enrolled at least in the first year of undergraduate studies.

Additionally, recent higher education graduates may participate in a traineeship. Recent graduates must be selected by the UP for mobility in their last year of study and must carry out and complete the traineeship abroad within one year of obtaining their graduation.

Students, who have not yet used 12 months of mobility under Erasmus LLL, Erasmus Mundus and/or Erasmus+ programme at their current cycle in study year 2020/2021, can apply to an open call.

A student can participate in mobility periods totalling to 12 months maximum per each cycle of study, independently of the number and type of mobility activities.

Period and duration of the mobility

Traineeships can last **at least 2** and at most **12 months at each study cycle (ie. undergraduate, master and doctoral studies) and should be concluded by 31 May 2021 at the latest.**

Destination countries for mobilities

Mobilities can be implemented in EU countries*, Liechtenstein, Turkey, Norway, Iceland, Republic of North Macedonia.

* United Kingdom: Although the United Kingdom is no longer a member of the EU, mobility can still take place until the end of the Erasmus + 2014-2020 program scheme.

Students must carry out their mobility activity in a country different from the country of the sending organisation (Slovenia) and the country where the student has his/her accommodation during his/her studies (temporary or permanent residence).

Traineeship must be related to the area of student's studies. Traineeships can be implemented in all enterprises, governmental or nongovernmental organisations and other institutions, except in EU institutions and other EU bodies (the list of these institutions is available here: https://europa.eu/european-union/about-eu/institutions-bodies_en) and organisations managing EU programmes such as Erasmus+ national agencies.

AWARDING EU GRANTS:

EU grants are allocated to each candidate provisionally for two (2) months following the following scheme:

Selected candidates are eligible for grants under this call, if the host institution accepts them for mobility and their mobility is also successfully concluded.

The rights, obligations and responsibilities of the contract parties will be more specifically defined in the Grant Agreement, which the student signs with the UP before leaving for mobility abroad.

SUBMITTING APPLICATION

The applicant must submit the following documents:

- **Application: students can access on-line application through the Student Information System (»ŠIS«) of their faculty;**
- **Learning Agreement for Traineeships (Annex 1), signed by the student, the responsible person of the student's home faculty and the responsible person of the host institution;**
- **Short CV in Slovenian OR English language (students must use the Europass CV form, available at <http://www.europass.si>);**

SUBMITTING APPLICATIONS

The candidate submits his/her application by filling-in the on-line application »Additional Application Erasmus+ KA103 for traineeship mobility (contract year 2018) in the academic year 2020/2021« (PRIJAVA za DODATNI RAZPIS ERASMUS+ KA103 za praktično usposabljanje (pogodbeno leto 2018) v študijskem letu 2020/2021) and submitting it electronically with the requested documents.

When a candidate submits the online application, he/she informs the coordinator at his/her faculty (by sending a notification to the appropriate e-mail address - see the contact details in the Additional Information section).

The deadline for submitting the applications is defined as the open deadline and starts on the day of the announcement of the Call and lasts until the available funds and by 04.03.2021 at the latest.

Only complete applications will be considered. The application is complete if it is submitted online and contains all required documents.

For co-financing, candidates will be selected whose applications will meet the conditions of the Call, in the order of the received complete applications according to the date and time of submission of each complete application up to the available funds.
